

**Bioequivalence Requirements for Generic Products Containing Scheduled Poison in Dosage Forms of Effervescent, Dispersible, Orodispersible, Sublingual, Lozenges, Buccal and Chewable Tablets/ Capsules**

The Drug Control Authority (DCA) in their 284<sup>th</sup> meeting, has decided to enforce the bioequivalence (BE) requirements on generic products containing scheduled poison in dosage forms of effervescent, dispersible, orodispersible, sublingual, buccal and chewable tablets/ capsules effective from 1<sup>st</sup> January 2018 for all new product application/submission. This requirement is also applicable for registered products with renewal due date from 1<sup>st</sup> January 2019 onwards.
